The following is a report of the work of the Office of Congressional Ethics ("OCE") in the fourth quarter of 2024 for the 118th Congress.

The OCE is an independent, non-partisan entity charged with reviewing allegations of misconduct involving Members, officers and staff of the House and, when appropriate, referring matters to the House Committee on Ethics. #### **Key Takeaways**

- In the 118th Congress, nine of the twenty-three reviews authorized by the OCE Board were transmitted to the House Committee on Ethics for further review. Of the 14 remaining authorized reviews, 8 were terminated in the preliminary review phase and 6 were dismissed by the Board after the conclusion of a second-phase review.
- In the fourth quarter of 2024, the OCE added an interactive investigations table to its website. The table lists all public OCE reports.
- In the fourth quarter of 2024, the House Committee on Ethics announced 45-day extensions for two matters referred to them by the OCE. The matter involving Rep. Andy Ogles is scheduled for release in the 118th Congress. The matter involving Rep. Cory Mills is scheduled for release in the 119th Congress.
- In the matter regarding Rep. Cherfilus-McCormick, transmitted to the Committee
  on Ethics by the OCE on September 25, 2023, the Investigative Subcommittee has
  not yet concluded its review. Accordingly, the OCE's referral containing findings
  of fact shall be made public before the end of the 118th Congress. The release of
  the report in a second OCE referral related to Rep. Sheila Cherfilus-McCormick
  will occur by May 29, 2025 if the Investigative Subcommittee has not yet
  concluded its review, with the release of the full referral required by the end of the
  119th Congress.

## **B. OCE ACTIVITY SINCE INCEPTION**

The following is a statistical summary of the Board's actions since the OCE began conducting investigations in February 2009. Of the 258 investigations the office began, approximately 43.0 percent have been referred to the Committee on Ethics for further review, approximately 53.9 percent have been terminated or dismissed, and approximately 0.4 percent have been referred as unresolved. For 2.7 percent of investigations, the OCE lost jurisdiction during preliminary review.

The following is a graphical explanation of the categories of preliminary reviews conducted since the OCE's inception through the end of the 118th Congress. The categories are defined by the House Ethics Manual<sup>5</sup>:

Chapter 3: Travel
Chapter 4: Campaign Activity
Chapter 5: Outside Employment and Income / Activities on Matters of Personal Interest
Chapter 6: Financial Disclosure
Chapter 9: Official Allowances

#### **CITIZEN COMMUNICATIONS**

Any member of the public may bring a matter of suspected misconduct involving a Member, officer or staff of the House to the attention of the OCE. The OCE received approximately 29,751 communications from private citizens during the 118th Congress. The OCE has received approximately 88,010 communications from private citizens since its inception. These communications include requests for information about the OCE and its procedures, as well as submissions of information regarding allegations of misconduct.
